- 1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize or affiliate the school beyond Class VIII.
- 2. The School shall abide by the provision of Right of Children to free and Compulsory Education rule. 2011 (Annexure-II).
- 3. The Society / School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.
- 4. The School shall not deny admission to any child
  - (i)For lack of age proof.
  - (ii)If such admission is sought subsequent to the extended period of 90 day for admission.
  - (iii) On the ground of religion, Caste or race, place of birth or any of them
- 5. The School shall ensure that,
  - No child admitted shall be held back in any class or expelled from school till the completion of Elementary Education in that school. (ix)
  - No child shall be subjected to physical punishment or mental harassment. (x)
  - No requirement to pass any Board examination till the completion of Elementary

Sir.,

Please refer to your application for grant of permission to run/establish a private Educational Institute.

In this regard permission to run/establish (NOC)

Dayer Shankar Public School Daddi Bohla

Nalagarh for standard 6th to 16th.

in favour of the society is granted to seek affiliation to H.P.Board of school Education Dharamshalo District Kangra (HP).

The grant of this permission/NOC shall however not entitle the school to any grant-in-aid from the Deptt./Govt. of H.P.

The grant of this permission/NOC is issued subject to the following conditions: -

- No pupil shall be refused admission on account of his caste creed or religion and the pupil who has once been admitted shall not be treated differently from the other fellow pupils of his caste creed or religion.
- 2. No pupil shall be compelled to attend a class in which a religious instruction is given or take part in any religious exercises.
- 3. The school with its account books, registers and other records shall be open to inspection at all reasonable hours by the authorised officer of the Deptt. Executive Officers of the Govt, authorised to inspect schools and Health Officer deputed by the Health Department to examine the Health of the student or sanitary conditions of the Building and premises.
- 4. The school shall have to furnish all information and returns as called for by the Department of Education from time to time.
- 5. The school shall comply with the rules of the Department and directions as given by the Department so far as they are applicable to private schools in the interest of maintaining standard. The Department of Education shall have the authority to send any of his officer for inspection for proper maintenance of educational standards, holidays as per state Govt. etc.

6. The private Institutions shall employ only the trained/eligible staff on the same pattern in which appointments are made in the Government Institutions in

accordance with the Raf rules of each category and norms laid about a

- 7. No private institution shall function with in the premises of existing Government institution.
- 8 Permission to run or establish a private Educational institution shall be granted only on individual basis and no permitted institution shall be entitle to open its branches elsewhere.
- 9. Admission in the institution shall be made strictly in accordance with the norms as laid down by the board of school Education to which the school is affiliated.
- 10. Teaching/Non Teaching staff shall be paid salary commensurate to the fees and funds to be charged from the students, donations and other sources of income of institution.
- 11. All the posts to be filled shall be advertised at least in two leading National daily newspapers or getting sponsorship of names from the nearest employment exchange giving full details of the qualifications required and scale of pay and allowances to be given.
- 12. Every private educational institution shall bring out prospectus giving full details of the management running the institutions, details of the staff their qualifications. fees, funds and donations to be charges from the students and other relevant information about the institution and shall also contain the permission of the govt to establish and run the institution.
- 13. Proper record of the receipt books to be used for charging fees and funds and other income etc. shall be maintained properly.
- 14. All the members of the staff shall be paid their salaries and related arrears through Account pavees bank cheques only.
- 15. Fees funds shall be such that they are not of exploiting nature but contribute to the spread of education. They should be commensurate to the salary of the the staff being paid, development of infrastructure and facilities and activities being provided to the students.
- 16. Each private educational institution shall form Parent Teacher Association, the parents and Teachers being its members. It shall have its executive body with 2/3 members from amongst parents and 1/3 members from Teachers. It shall be of advisory nature and still strive for the better running of the institution and cordial relation between management parents and teachers.
- 17. Each Teacher shall be given workload in such a manner that it does not exceed 24 hours in a week in any case. In case of non teaching staff it shall be 7 hours (42 hours in a week).
- 18. The school staff and students shall not take part in any agitation directed against the authority of Govt, or disseminate opinions tending to excite feelings of disloyalty or disaffection against the Govt, or of enmity and hatred between different communities.

The breach of any of the conditions specified above shall render the school defaulter and the Department of education after conducting any enquiry through any of the officers so designed by him, shall have the power to cancel the permission to run/establish a private Educational Institute.

On the careful consideration of the inspection report submitted by the Inspection Committee vide letter No. EDN-SLN (E-III)02/2013-(NOC)-49114 dated 06-02-2017 constituted for the purpose of inspection of Private Educational Institutions of the School level for grant of permission to run/establish a private educational institution by the Govt. of H.P. Shimla vide Notification No.-Shiksha-II-Chha(11)-2/2005-L dated 03-05-2006 and in exercise of the powers vested in me vide Govt. Notification No. Shiksha-II-Chha 5P-3/97 dated 16-01-2007, the approval of competent authority with regard to issue of Permission for establishment/running/up gradation of private Educational Institution in respect of "Daya Shankar Public School Managing Committee, Vill. Daddi Bhola, PO & Tehsil Nalagarh, Distt. Solan (H.P.)-174101" registered under as per the provision of Registration Act, 2006 (Registration No-NLG/SDM/HC/2016-425) on dated 22-12-2016 for the establishment of "Daya Shankar Public School, Daddi Bhola, Nalagarh, Tehsil Nalagarh, District. Solan H.P.-174101" for 10+1 to 10+2 (Science and Commerce Streams) classes from the academic session 2017-18 (if the affiliating Board find fit) is conveyed subject to the following terms and conditions:-

- That the school concerned shall be affiliated to H.P. Board of School, Education 1. Dharamshala for 10+1 to 10+2 (Science and Commerce Streams) classes.
- That the State Govt. will not provide any type of financial assistance/Grant-in-aid etc. 2. in respect of the said institution.
- That the admission in the institution shall be made strictly in accordance with the 3. norms as laid down by the Board of School Education to which the school is affiliated and no discrimination on the basis of caste, colour, creed and sex shall be made. No pupil shall be refused admission on account of his caste, creed or religion.
- That the private institution shall employ only the trained/eligible staff as per the norms 4. fixed by the Govt.
- That no particular religious education shall be imparted by the institution to maintain 5. secular character of the institution.
- That the fees and funds shall be such that they are not of exploiting nature but 6. contribute to the spread of education. They should be commensurate to the salary of the staff being paid, development of infrastructure and facilities and activities being provided to the students. (Donation in any form from the student is strictly prohibited).
- That the permission to run or establish a private educational institution shall be 7. granted only on individual basis and the institution shall not be entitled to open its branches elsewhere.
- That the institution shall maintain proper record accounts and register in accordance 8. with norms of HP Govt. As stated in chapter III of the Himachal Pradesh Private

Educational Institutions (Regulation) Act, 1997 and Notification No. Shiksha-II-(Ga) 6-1/98 dated 10-06-2008 Corrigendum of the same.

That the institutions shall have to comply with the norms/provisions of the H.P. Private Educational Institutions (Regulation) Act, 1997 and rules notified by the Govt. vide notification No. Shiksha-II-(Ga)6-1/989 dated 19-10-2004 corrigendum dated 10-06-2008 and the instructions issued by the competent authority from time to time.

That the school shall have to furnish all information and returns as called for by the Department from time to time.

11. That the society will make efforts to acquire its own land and establish the institution in its own land.

12. That the recruitment of staff will be made after following proper procedure i.e. by advertisement at least in two leading national daily newspaper and getting sponsorship of names from the nearest employment exchange giving full detail of the qualifications required and scales of pay plus allowances payable by the school.

13. That the salary of staff is to be paid strictly through RTGS/on line system only.

14. It should be mentioned noticeably/highlighted in the prospectus of the institution, details of the staff & their qualifications, fees, funds and other relevant information about the institutions and information regarding grant of permission of the Govt. To establish and run the institution.

15. That the name of the affiliating Board of the institution should be mentioned in the prospectus with Approval No. Registration No. And Affiliation No. the same should also be displayed on the notice boards of the institutions, at least 2-3 places visible easily to all.

16. That the Society will provide the facility of provident fund as per the EPF norms to its staff and also will take up welfare programme for the employees and students as well.

The breach of any of the conditions specified above shall render the "Daya Shankar Public School, Daddi Bhola, Nalagarh, Tehsil Nalagarh, District. Solan H.P.-174101" defaulter and the action for the withdrawal/cancellation of the permission so granted shall be initiated.
